

## **NFHS Rule 2 - Game Personnel - 2019**

1. A game will not be continued under which of the following conditions?
  - a. A team has fewer than 9 on field players due to injuries, players out on ejection fouls, penalties or other reasons.

## **NFHS Rule 3 – Time Factors - 2019**

1. After the first half, what is the proper procedure for starting running time?
